Self-Exclusion

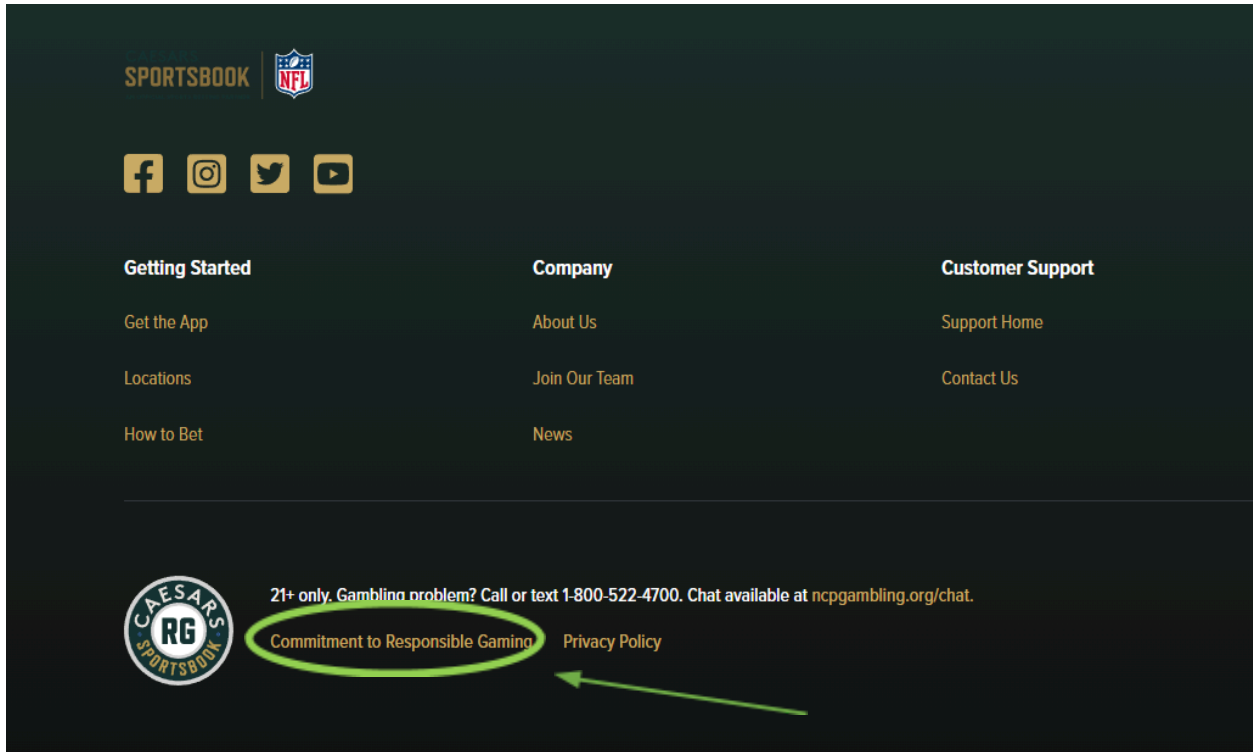
Self-exclusion is a tool for you, the consumer, to control your access to the sport wagering app or to your engaging in gambling at a casino. It is your tool to exercise you want to be in driver seat in creating a break. Our research has shown us that people have found this a valuable step in saying no to sport wagering or casino operator. People have also found great value in seeking help as part of self-exclusion. Perhaps it is time for you to take the steps you want to reduce those gambling harms.

Self-Exclusion

Caesars Sportsbook customers can self-exclude from further wagering for a minimum of twelve (12) months if they feel they have or may be at risk of developing gambling-related problems. Customers may exclude directly through a sports book or by mailing in a notarized Caesars Sportsbook Self-Exclusion form found [here](#). Once self-excluded, the customer will be banned by Caesars Sportsbook in the local jurisdiction. 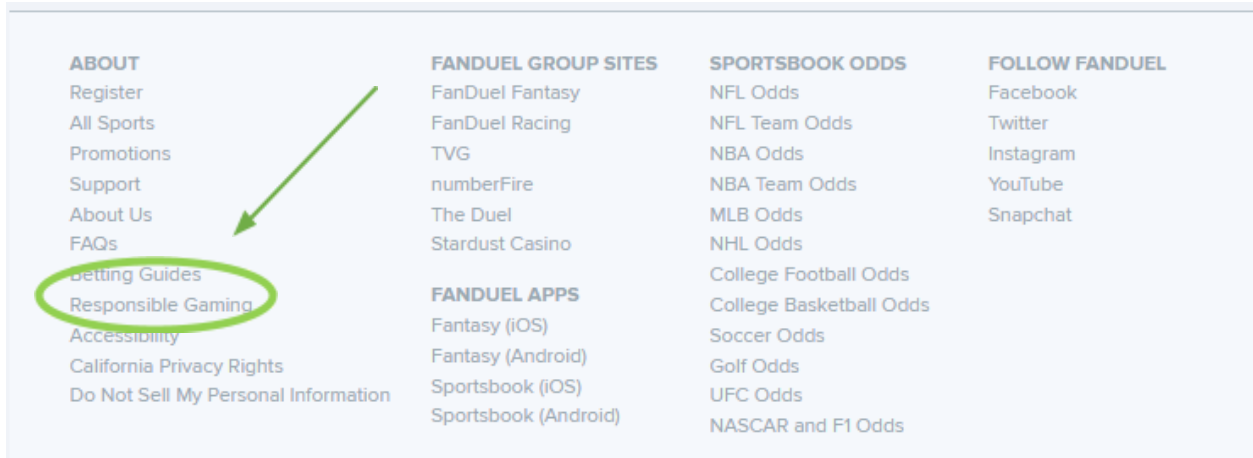

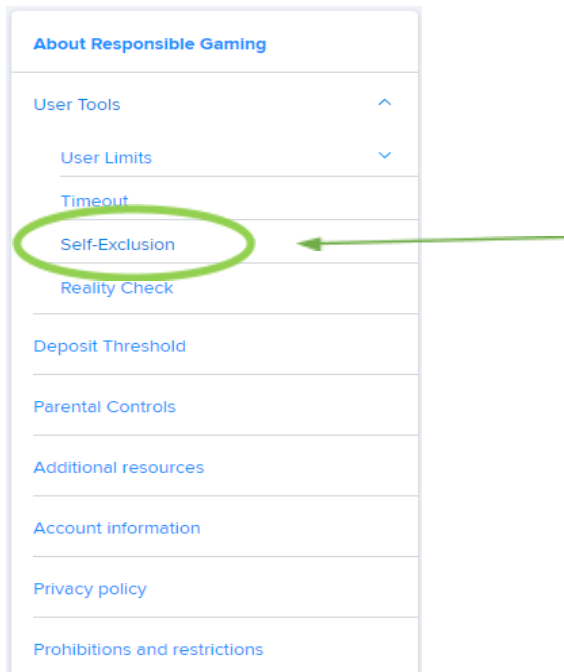



Once the document has been completely filled out, click “Submit request”:

- I understand that by checking this box I am authorizing FanDuel to share this self-exclusion request with the Tennessee Sports Wagering Advisory Council for the purpose of sharing the request with other licensees in Tennessee and being added to the other operators’ self-exclusion lists for the same duration.

- I acknowledge the fact that casino companies or interactive gaming operators may enact responsible gaming programs that are stricter than Tennessee’s Self-Exclusion program for Internet gaming. By way of example, a casino may enact a more restrictive responsible gaming program in which persons signing up for a particular self-exclusion list are banned from all of their casino properties and/or online sportsbooks worldwide for the length of the state self-exclusion. Any request for online self-exclusion COULD, at the sole discretion of the casino or interactive operator, also apply to land-based casinos and gambling facilities or other interactive gaming products. By initiating this online exclusion, I agree not to wager at any FanDuel Sportsbook retail facility or on any mobile FanDuel product. I understand that individual casinos and interactive operators have the right to change their responsible gaming programs to exclude me from their land-based casinos or interactive products even if I sign up only for the FanDuel Sportsbook online self-exclusion list. I understand the Tennessee Sports Wagering Advisory Council and FanDuel Sportsbook are not responsible for keeping me informed of any changes.

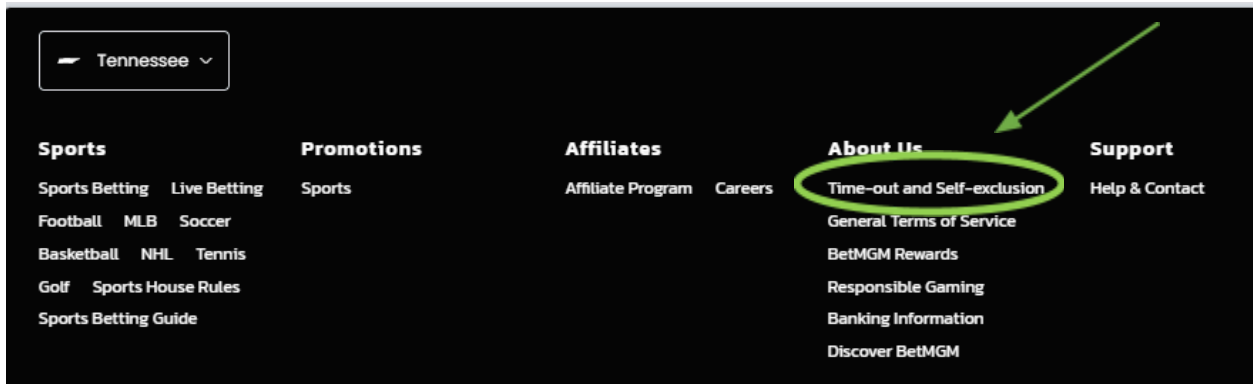

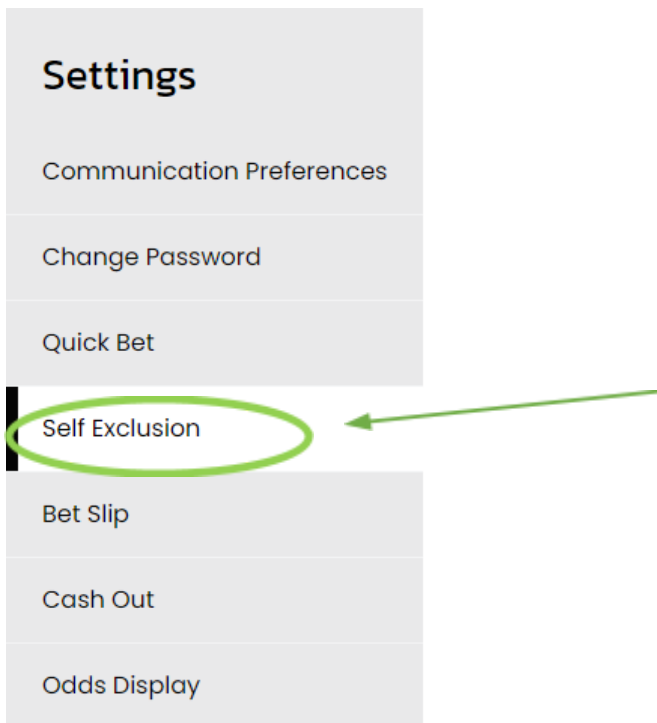

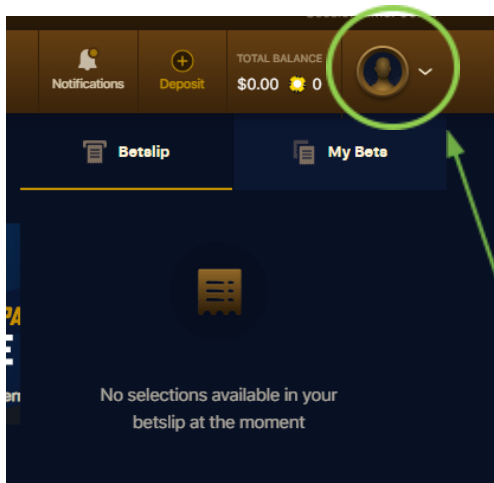

Self Exclusion

You may request to voluntarily exclude access to your online account by signing up for the Tennessee Self-Exclusion Program. If you choose to self-exclude, you will be restricted from accessing any sports betting, account-based lottery or gaming activities in Tennessee. Please note, any request to be removed from this Self-Exclusion list before the exclusion period has expired must be directed to the Tennessee Sports Wagering Advisory Council. After the self-exclusion period has expired, the account will be reactivated and available for use. If you would like to inquire about other Self-Exclusion options, please contact WynnBET customer support.

What happens when you self-exclude?

During a period of Self-Exclusion you will not be able to use your account for betting, although you will still be able to login and withdraw any remaining balance. It will not be possible to re-open your account for any reason. bet365 will do all it can to prevent new accounts being opened.

- You can self-exclude your account in the Gambling Controls section in the Account Menu by choosing Self-Exclusion.

To stop wagering for more than 1 year, you must self exclude. This exclusion will apply to all of your Tennessee sports wagering accounts.

Select My Profile -> Self-Exclusion and Limits -> Self-Excluded and press "Apply" under the Self-Exclude tab. Check all the acknowledgement boxes and press "I Agree" to move forward.

Select your time frame (1 year or 5 years). Enter your SSN and DOB and press "Submit".

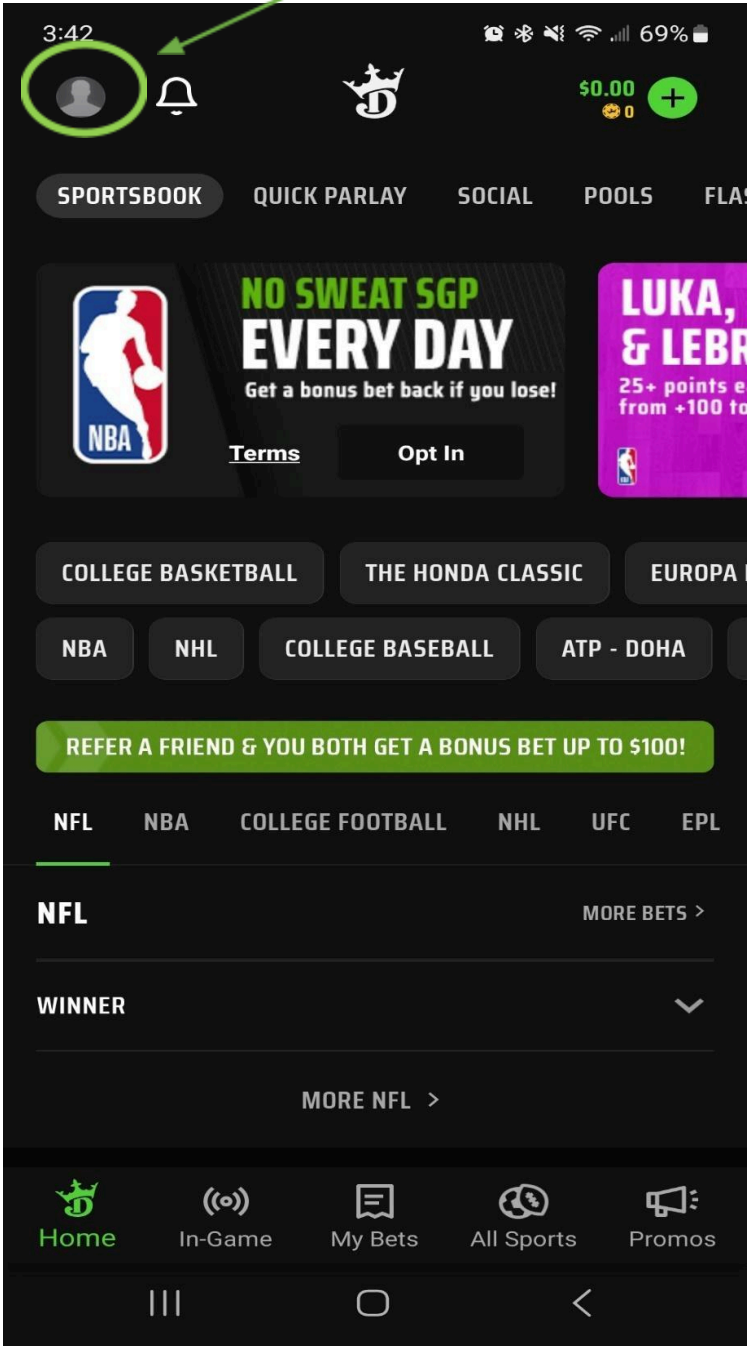

Self-exclusion FAQ

What is self-exclusion?

Self-exclusion is a personal ban from a gambling platform (casino, online sports betting, etc.). This process ends with a binding document which keeps the individual from participating in that platform. With land-based gambling locations, this means trespassing oneself from the property.

How does self-exclusion work?

Self-exclusion works by signing up for it through a specific gambling platform or the respective state's gambling commission. In some cases, when someone self-excludes from one casino, they are also banned from the same casino in different locations. In other cases, self-excluding from one platform will lead to self-exclusion from all gambling sites in the respective state. It is essential to read the self-exclusion criteria for each gambling platform carefully.

Am I banned forever if I self-exclude?

No. Though there are options in self-exclusion for lifetime bans, lengths of self-exclusion vary between platforms and the individual can specify the time of exclusion; in most cases this is either 1, 5, 10 years or a lifetime. You have the choice of how long this time will be.

Who signs up for self-exclusion?

This service is intended for those who might want additional help reducing gambling. Self-exclusion is a personal choice. Some individuals experiencing harms from gambling find it beneficial to create distance between themselves and the gambling platform of their choice.

Are there different kinds of self-exclusion?

There are different services that gambling platforms offer to reduce gambling harms. Among these include “time out” and “cool off” periods. These options are intended for those who would rather have a more temporary break

from gambling. These options can be anywhere between 24 hours to multiple months. It is important to note that criteria and time-periods vary by platform.

Can I sign someone else up for self-exclusion?

No. You must be the individual who initiates the self-exclusion process. No one can sign someone else up for self-exclusion. It is an entirely voluntary process.

What happens if I try to gamble after self-excluding?

If you gamble while self-excluding, you will likely violate the self-exclusion agreement. Any winnings may be voided. If you gamble during your self-exclusion period, we encourage you to seek professional help to reduce your gambling activities. Reach out to us at The Gambling Clinic to discuss a plan.
